Browser application to visualize relationships between your media services

Publication date: *December 2018* ([last update](#): *October 2023*)

Many Amazon Web Services (AWS) customers use media services to prepare, process, and deliver broadcast and over-the-top (OTT) streaming video from the AWS Cloud. While these services allow you to innovate, test, and deploy video services, it is difficult to quickly understand the relationships among several media services resources that are configured to operate together. Especially when multiple resources are reporting alerts or alarms through [Amazon CloudWatch](#), it can be a challenge to identify the source of the problem.

Media Services Application Mapper (MSAM) on AWS helps you visualize media service relationships and the real-time status of linear video services. This solution features a browser application that visualizes the relationships between your inventory and allows you to display the logical connections between media services. It also provides the status of related alerts and alarms that visualize error conditions in complex workflows to help you quickly navigate to the root cause for problematic workflows. The application features a tile view and a diagram view.

This solution also monitors the following supporting services that are often used with media services: [Amazon CloudFront](#), [Amazon Simple Storage Service](#) (Amazon S3), and [Amazon Elastic Compute Cloud](#) (Amazon EC2) and on-premises hardware configured with the [AWS Systems Manager](#) agent.

This implementation guide describes architectural considerations and configuration steps for deploying the Media Services Application Mapper on AWS in the AWS Cloud. It includes links to an

[AWS CloudFormation](#) template that launches, configures, and runs the AWS services required to deploy this solution using AWS best practices for security and availability.

The guide is intended for IT infrastructure architects, administrators, and DevOps professionals who have practical experience with media workflows and architecting in the AWS Cloud.

Features and benefits

The Media Services Application Mapper (MSAM) on AWS solution provides the following features:

Channel tiles

Aggregate resources into a single channel tile that represents a single streaming video channel. Each tile displays the aggregated media service configuration information for all resources included in the tile.

Workflow diagrams

Visualize the relationships between your media services and the status of your resources and pipelines as workflow diagrams. You can also customize the solution to include custom node types or on-premise equipment.

Customizable

You can customize or extend this solution for your specific needs. For example, add custom node types with the browser application, cache them into a database through a cloud-side task, and extend connection discovery and visualization overlay functionality to on-premise equipment.

Integration with AWS Service Catalog AppRegistry and AWS Systems Manager Application Manager

This solution includes a Service Catalog AppRegistry resource to register the solution's CloudFormation template and its underlying resources as an application in both [AWS Service Catalog AppRegistry](#) and [AWS Systems Manager Application Manager](#). With this integration, you can centrally manage the solution's resources.

Use cases

Media Processing and quality control

As content moves into and through the media supply chain, the produced content must go through a number of quality and accuracy control reviews. Media Services Application Mapper on AWS automatically provision resources to visualize workflow steps, their relationships, and their real-time status. This solution helps you identify the root cause of a problem when multiple services are used, and maintain a high level of quality each step of the way.

Concepts and definitions

Tile

A logical group of cloud resources that represents a single streaming video channel or other related collection of resources.

Workflow diagram

A graphical representation of cloud resources and the connections between them assembled by the user.

Microservices

A set of AWS Lambda functions that provide the business logic and data access layer for all operations in the solution.

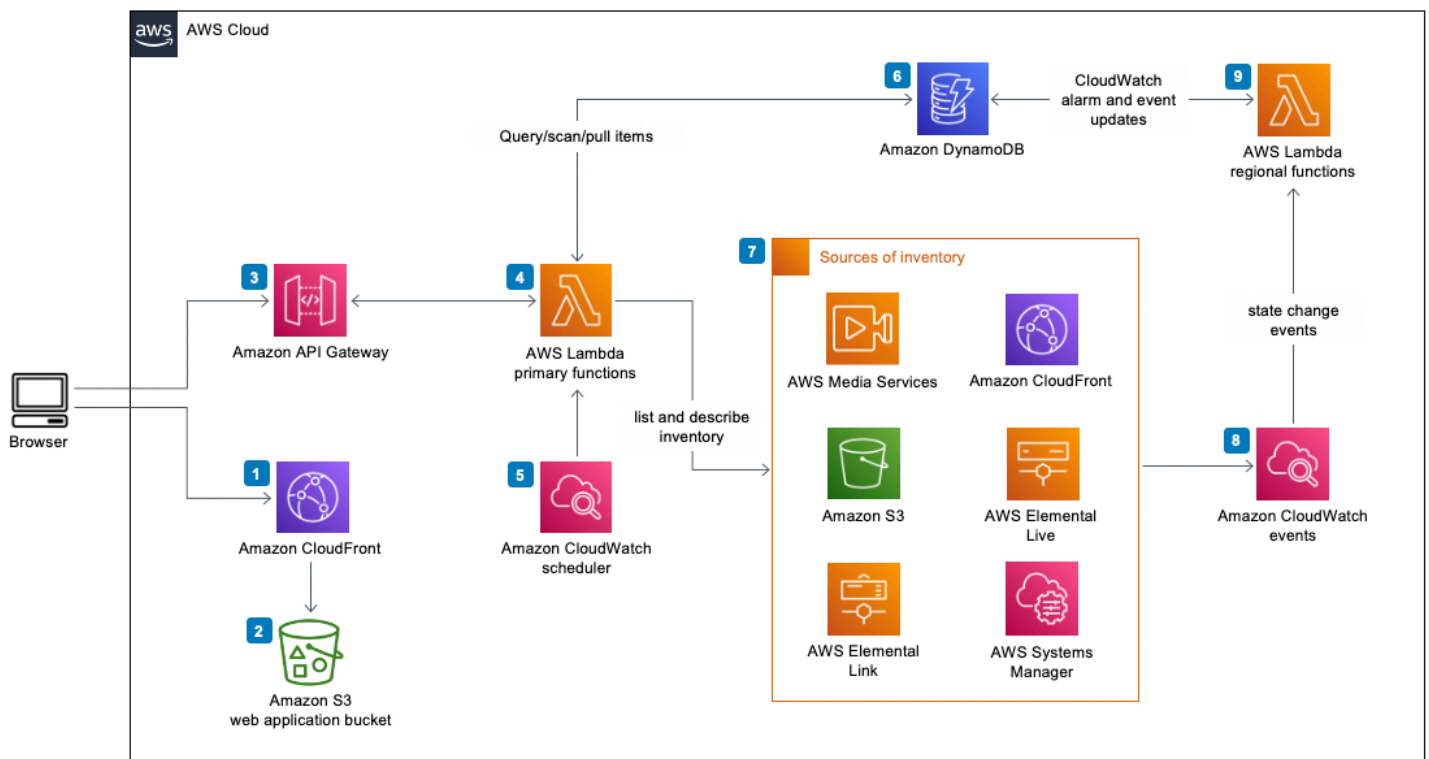

Architecture overview

This section provides a reference implementation architecture diagram for the components deployed with this solution.

Deploying this solution with the default parameters builds the following configuration of resources in the AWS Cloud.



Media Services Application Mapper architecture on AWS

The AWS CloudFormation template deploys the following serverless infrastructure and web content for Media Services Application Mapper (MSAM) on AWS:

1. An [Amazon CloudFront](#) distribution to serve the Media Services Application Mapper on AWS web application.

2. An [Amazon Simple Storage Service](#) (Amazon S3) bucket as an origin to serve the solution's web application.
3. [Amazon API Gateway](#) for inventory and monitoring queries to the solution's backend.
4. [AWS Lambda](#) functions to handle client REST API requests from API Gateway, periodically scan for media services resources, and receive notifications of changes in a resource's status. Two Lambda functions are custom resources for the browser application stack and one for the DynamoDB tables stack that are used during installation, update, and deletion.
5. [Amazon CloudWatch](#) scheduled rules or event patterns to invoke the primary Lambda functions.
6. [Amazon DynamoDB](#) tables to store the solution's backend and front-end configuration and state.
7. The AWS Cloud services and devices that this solution scans. The solution uses the AWS Elemental MediaLive API to discover AWS Elemental Link devices and the AWS Systems Manager API to discover Elemental Live encoders.
8. CloudWatch events to invoke the regional Lambda functions when there are operational changes in the sources of inventory or changes in state to subscribed CloudWatch alarms.
9. Lambda functions to monitor source services for CloudWatch events in additional AWS Regions.

Note

Requests to and responses from the APIs are logged in Amazon CloudWatch. Lambda functions invoked by scheduled events or notification events also send log data to Amazon CloudWatch.

AWS Well-Architected design considerations

This solution was designed with best practices from the AWS Well-Architected Framework which helps customers design and operate reliable, secure, efficient, and cost-effective workloads in the cloud. This section describes how the design principles and best practices of the Well-Architected Framework were applied when building this solution.

Operational excellence

This section describes how we architected this solution using the principles and best practices of the [operational excellence pillar](#).

The Media Services Application Mapper on AWS solution pushes metrics to Amazon CloudWatch at various stages to provide observability into the infrastructure; Lambda functions, AWS S3 buckets, and the rest of the solution components.

Security

This section describes how we architected this solution using the principles and best practices of the [security pillar](#).

All browser actions are performed through an authenticated and SSL encrypted REST API hosted in the cloud. The API can be used by other tools to perform activities such as preloading tile definitions or adding custom content to the cache.

To support multiple users in Media Services Application Mapper on AWS, you can create multiple API keys, each with different names that are provided to separate groups. To share the browser application with a colleague, provide the browser application URL, core endpoint URL, and an API key.

Reliability

This section describes how we architected this solution using the principles and best practices of the [reliability pillar](#).

Media Services Application Mapper on AWS uses AWS serverless services wherever possible (for example: Lambda, API Gateway, S3, and DynamoDB) to ensure high availability and quick recovery from service failure.

Performance efficiency

This section describes how we architected this solution using the principles and best practices of the [performance efficiency pillar](#).

Media Services Application Mapper on AWS, as mentioned earlier, uses serverless architecture throughout the solution. It can be launched in any region that supports the AWS services used in the solution such as: AWS Lambda, Amazon API Gateway, AWS S3, and the AWS Elemental services that it supports.

This solution is automatically tested and reviewed by solutions architects and subject matter experts for areas to experiment and improve.

Cost optimization

This section describes how we architected this solution using the principles and best practices of the [cost optimization pillar](#).

Media Services Application Mapper on AWS uses serverless architecture; therefore, customers only get charged for what they use. The total cost of the solution depends on the size of the resource inventory and the monitoring activity.

Sustainability

This section describes how we architected this solution using the principles and best practices of the [sustainability pillar](#).

Media Services Application Mapper on AWS utilizes managed and serverless services to minimize the environmental impact of the backend services. The serverless design using Lambda, API Gateway, S3, and DynamoDB is aimed at reducing carbon footprint compared to the footprint of continually operating on-premise servers.

Architecture details

Browser application

The browser application visualizes the relationships between your inventory. Configure your environment with the tile view and diagram view according to your needs.

Tiles

Tiles aggregate several cloud resources into a single visual item that represents a single streaming video channel or other related collection of resources. Multiple square tiles are displayed in a grid and can be filtered by state. You can create single tiles through the browser application or multiple tiles in bulk with the solution's RESTful API.

Example channel tiles

Each tile displays the aggregated media service configuration information for all resources included in that tile. You can also select the tile to view the tile's resources on an existing diagram, or choose to create one on-demand. When you choose the diagram button on the tile, it searches for diagrams containing all the tile's resources, and allows you to select a matching diagram or generate a new diagram with the tile's resources.

The following image shows the aggregated JSON configuration of all the cloud resources assigned to the tile. This output is shown in the **Selected Item** compartment when the tile is selected with the mouse.

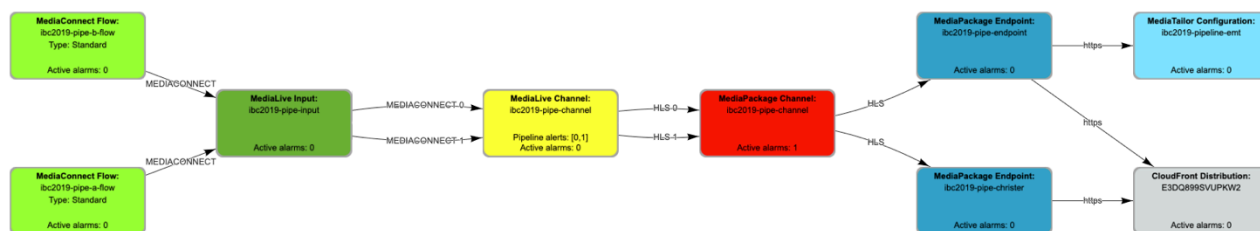

Diagrams

The application visualizes your resources and connections as workflow diagrams that are assembled by the user. Diagrams can be organized in any way that makes sense for your environment and required level of detail. The browser application includes features to navigate, find, and build diagrams of related cloud resources. It visualizes cloud resources as nodes and the logical connections between resources as directed edges.



Example workflow diagram

The application includes two default automatic layout configurations: vertical (top to bottom) and horizontal (left to right). You can also select and move individual items or groups of items to new

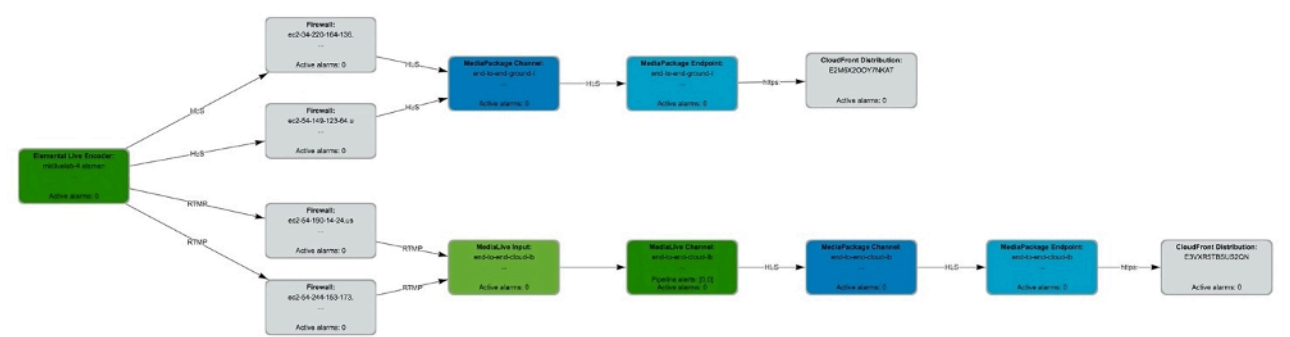
locations to create your own custom layout. When you move items, the layout is saved in the cloud so all users will be able to view the same diagrams at the same endpoint.

Furthermore, the solution's diagram tool features the following:

- Edges (connections) on diagrams generally represent some type of data flow in the direction of the arrowhead.
- Resources with redundant data paths are drawn with multiple, labeled connections.
- Different types of service resources are visualized with unique color and textual indicators.
- Graphical tools available through the menu to quickly build diagrams of related resources.
- The solution provides configuration data for each resource on the diagram in the **Selected Item** compartment at bottom of the page.

The solution is designed to be extended with new node types, connection discovery, visualization overlays, and tools. You can add custom nodes within the browser application directly, or cached into a database through a cloud-side task.

Solution microservices

The Media Services Application Mapper on AWS microservices are a set of AWS Lambda functions that provide the business logic and data access layer for all solution operations. The browser application and other custom applications can interact with solution data securely through the RESTful APIs to perform activities such as creating diagrams and tiles, associating inventory items with alarms, and receiving alert notifications when a monitored item changes state.

Each Lambda function assumes an AWS Identity and Access Management (IAM) role with least-privilege access to perform its designated functions. The following sections outline each microservice.

API Handler microservice

The `APIHandler` Lambda function handles all browser requests and interacts with the solution's Amazon DynamoDB tables in the browser application. The `APIHandler` Lambda function also handles all administrative services including layout management and general settings.

Inventory discovery microservice

An Amazon CloudWatch event invokes the `UpdateNodes`, `UpdateSSMNodes`, and `UpdateFromTags` Lambda functions every five minutes. These functions scan for your media services and related services resources, and store information about the resources in the Content DynamoDB table.

An Amazon CloudWatch event invokes the `UpdateConnections` Lambda function every five minutes. The function identifies connections between your media services, and stores any connections it could determine in the `Content` DynamoDB table.

The `UpdateFromTags` Lambda function is also invoked every five minutes and updates diagrams and tiles based on tags present in the discovered inventory.

The `SSMRunCommand` and `ProcessSSMRunCommand` Lambda functions are invoked every five minutes and used to periodically gather state from AWS Systems Manager managed instances.

When a user accesses the browser application, the `APIHandler` Lambda function retrieves the resource and state information from the DynamoDB tables and displays the resources, their connections and state in the browser through diagrams and tiles.

CloudWatch Events microservices

CloudWatch Events rules receive an event when there is a change in your media services or their status, and then route the event to the `Collector` or `AlarmUpdater` Lambda functions. These functions track alert or alarm state for inventory nodes in the DynamoDB tables. When a user accesses the browser application, the `APIHandler` Lambda function retrieves the alert or alarm information from the `CloudWatchEvents`, `Events`, or `Alarms` table and displays it in the browser.

Resource monitoring

The solution can be configured to automatically display MediaLive Channel, Multiplex, and MediaConnect alerts. It integrates with CloudWatch alarms to indicate operational problems from a top-down view. Any CloudWatch alarm can be associated with any node on the diagram. CloudWatch alarm indicators are visualized as color and text on the node. CloudWatch high-resolution alarms can be used for frequent ten-second notification intervals.

The following image shows MediaConnect flows sending to a MediaLive input, a MediaLive channel with an alert status on one of two pipelines shown in yellow, and a MediaPackage channel with a custom alarm condition.

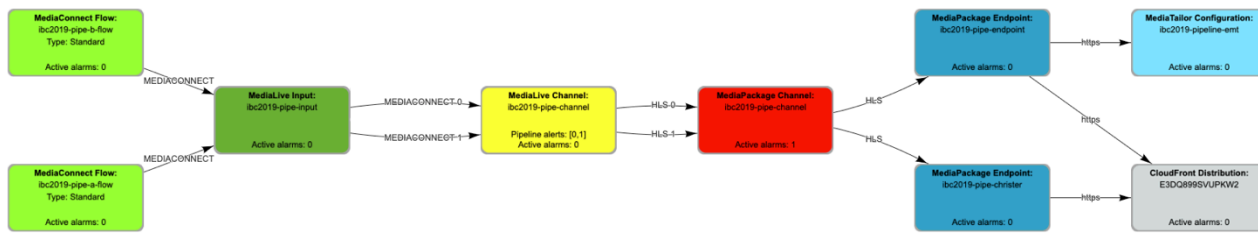


Diagram with alerts for monitoring

The tabs shown in the lower compartment are based on the resource type selected in the diagram. MSAM provides three tabs in the lower compartment for **Pipeline Alerts**, **Subscribed Alarms**, and **Recent CloudWatch Events** history. Select the **Recent CloudWatch Events** tab to view event details for the currently selected diagram node.

Note

The **Pipeline Alerts** tab only shows when you select MediaLive resources.

A tile aggregates all structure, configuration, and status from the underlying assigned resources. If any resource's CloudWatch alarm assigned to a tile goes into alarm status, the tiles associated with that resource will also show the same status. The same is true for any MediaLive resource contained by the tile that sets an alert state.

Tiles with alarms

Custom resources

The `DefaultSettingsResource`, `WebContentResource` and `WebInvalidationResource` Lambda functions are custom resources used by CloudFormation during installation of the solution.

Amazon DynamoDB

The Media Services Application Mapper on AWS provisions several DynamoDB tables during initial deployment: `Alarms`, `Channels`, `CloudWatchEvents`, `Content`, `Events`, `Layout`, `ResourceNotes`, and `Settings`.

DynamoDB tables and their purposes:

- `Alarms` - stores alarms states
- `Channels` - stores tile definitions
- `CloudWatchEvents` - stores recent events for monitored inventory
- `Content` - stores cached inventory collected from the various AWS services

- Events - stores media services alerts and their status
- Layout - stores diagram layout information for the browser application
- ResourceNotes - stores notes for tiles, monitored inventory, and its connections
- Settings - stores general settings information for the cloud processes and browser application

Read and write capacity

By default, this solution sets the Amazon DynamoDB read/write capacity mode to on-demand for all tables created for the application. This setting allows the table read and write capacity to scale for variable sizes of inventory while remaining billed by total reads and writes. For more information, refer to [Read/write capacity mode](#) in the *Amazon DynamoDB Developer Guide*.

Note

We recommend setting alarms and notifications for throttling errors, if utilization exceeds 75%, or if any table exceeds read/write capacity units.

Encryption

Each DynamoDB table and all indexes are configured for encryption at rest using AWS Key Management Service (AWS KMS) and the KMS key for DynamoDB in your account.

Point-in-time recovery

Each DynamoDB table is configured for point-in-time recovery. The recovery window, set by AWS, is up to five calendar weeks. This window size is set by AWS. You can use this type of recovery to restore one or more copies of a table to a known place in time, and then use the [DynamoDB table migration tool](#) to copy data back into the live tables after reviewing the restored results.

For more information, refer to [Point-in-Time Recovery for DynamoDB](#) in the *Amazon DynamoDB Developer Guide*.

REST API

All browser actions are performed through an authenticated and SSL encrypted REST API hosted in the cloud. The API can be used by other tools to perform activities such as preloading tile definitions or adding custom content to the cache.

Plan your deployment

This section describes the cost, architecture, network security, and other considerations prior to deploying the solution.

Cost

Security

Multiple users and access control

You can create multiple API keys, each with different names that are provided to separate groups. To share the browser application with a colleague, provide the browser application URL, core endpoint URL, and an API key.

Important

If an API key is stolen or lost, create a new API key and delete the previous one. Send the updated API key by method of your preference to all users that require access. All users will have to update in the browser application. This solution's browser application prompts the user to update the endpoint and key if the previously used settings are unable to access the back-end.

Installation permissions

The CloudFormation templates provided for solution installation require permissions to create and configure several different types of cloud resources. The user launching the CloudFormation templates must have permissions to create the resources defined in the templates. CloudFormation will assume that user's permissions temporarily during installation to complete the steps.

There are several options for the user installing the templates to have the correct permissions:

1. A user with AdministratorAccess role attached.
2. A user that belongs to the `installationGroup` created by the IAM template.
3. Using the root user if no other options are available.

Important

Using the root user is generally discouraged. For details, refer to [AWS account root user](#) in the *IAM User Guide*.

IAM resources

The solution's IAM template installs a group with an inline policy with permissions sufficient to install all the templates of the solution. The IAM group is named `<stackname>-installationGroup-<ID>`. Add the users to this group who will be installing the solution if your organization has strict requirements about the AdministratorAccess managed policy.

Deploy the solution

This solution uses [AWS CloudFormation templates and stacks](#) to automate its deployment. The CloudFormation template(s) describes the AWS resources included in this solution and their properties. The CloudFormation stack provisions the resources that are described in the template(s).

The Media Services Application Mapper on AWS is designed to be customized or extended. Configure the browser application

When you launch this solution's browser application it prompts you for an endpoint URL and API key. The tool confirms that the connection information is valid before continuing. You can save several endpoints in browser storage for reuse later. If you launch the browser application and it finds a previous connection, it will automatically use that connection on the next launch.

1. Open a new browser tab and use the URL value from the **MSAMBrowserURL** output obtained earlier.
2. In the API Endpoint Connection box, enter the **EndpointURL** value and **API key**, also obtained earlier.

Select the **Remember** check box to store the endpoint and API key for recall after the browser is closed. Uncheck **Remember** to use this endpoint and API key only during the current browser session.

3. Choose Connect.

Individual templates

Depending on your needs, the solution allows you to install the CloudFormation templates separately. 1. Create the IAM resources stack.
2. Create the DynamoDB tables stack.

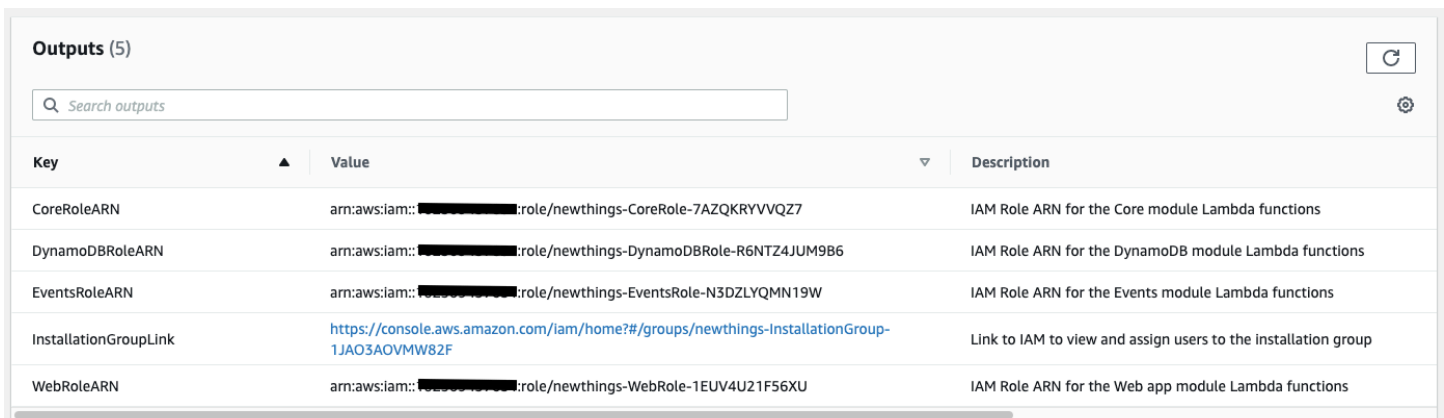

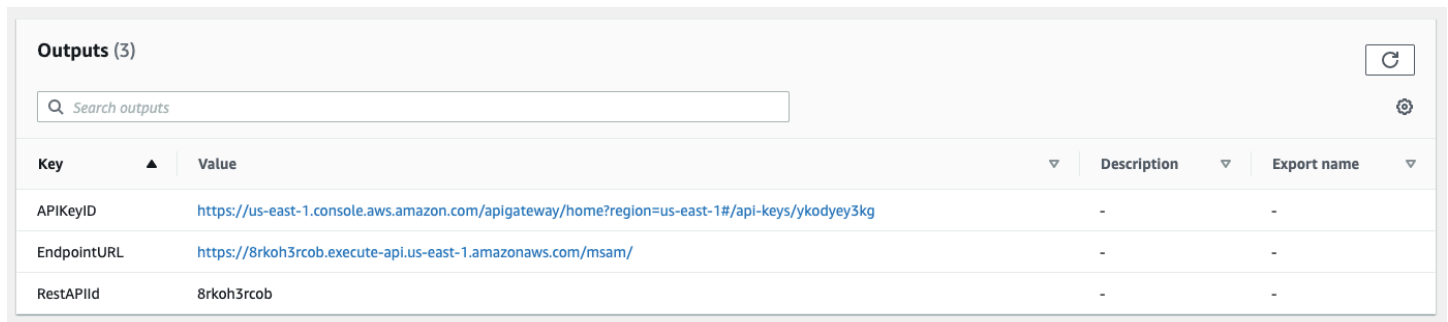

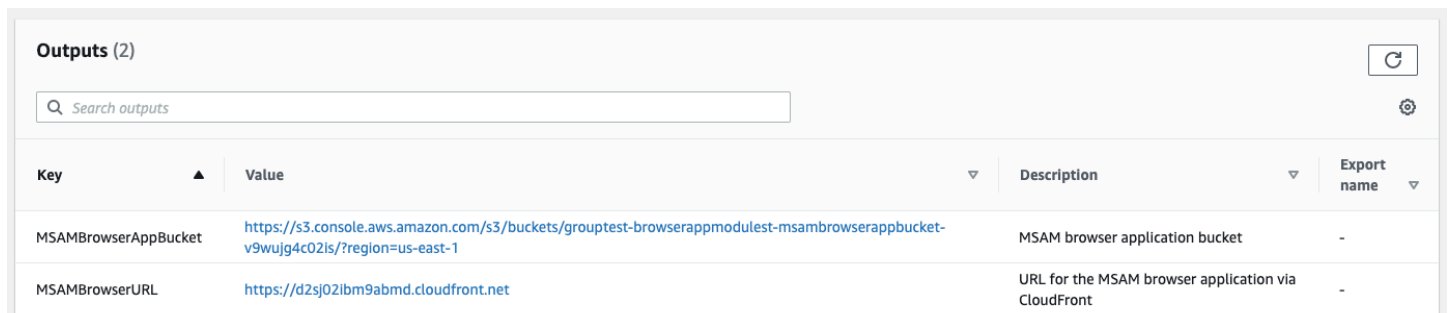

Important

Use these parameters only for secure or demonstration environments. Anyone using a URL with endpoint and key parameters can connect and use the solution and share the URL with more users.

Using the browser application

When you first launch the web application, the solution creates a default tile. To visualize your cloud resources, add new tiles or create diagrams. You can create new tiles and diagrams from the inventory dialog, search results or the contents of existing diagrams and tiles.

Working with tiles

A tile represents all of the cloud resources that make up a streaming channel, system or other related collection of resources that should be monitored together in your environment. Any resource, such as an Amazon S3 bucket or CloudFront distribution, can belong to more than one tile. The alerts and alarms of a tile's resources are aggregated and communicated by visual indications on the tile.

Tiles are sorted by the total number of alarms and alerts, and then by tile name. Tiles are periodically updated to visually reflect the state of subscribed alarms and alerts. The following image of the tile tab shows several tiles with one indicating an alarm and a selected tile (**Broadcast01**) with details in the compartment.

Set a tile's preferred diagram

By default, a tile has no set preferred diagram. To set a tile's preferred diagram:

1. Select the icon at the bottom right of the tile to open the dropdown list.
2. Right-click one of the tile's matching diagrams.
3. Choose **Proceed** to confirm the selection.

Set preferred diagram for a tile

Create a tile

There are several ways to create a tile: adding a new tile, creating a copy from an existing tile, and creating a tile from a diagram, with all its contents.

Add a new tile

1. From any tab, choose **Tiles**, and then **Add New Tile**.
2. Enter a name for your tile and choose **Proceed**.

Create a copy of a tile

1. On the **Tiles** tab, drag an existing tile to the white background, choose **Proceed**.

2. Enter a name for your tile and choose **Proceed**.

Create a tile with the diagram's contents

1. On the **Tiles** tab, drag the tab of an existing diagram to the tile tab white background, choose **Proceed**.
2. Enter a name for your tile and choose **Proceed**.

Note

Tiles automatically update every few seconds to show the latest status, and every few minutes (check **Advanced Settings**) to update the inventory of tiles.

Update tile contents

There are several ways to add inventory to a tile.

- Use the keyword search at the top right of the page and drag results from the bottom of the page to the tile, choose **Proceed**.
- Drag one tile on top of another tile to copy inventory from one tile to the other.
- Drag a diagram tab on top of a tile to copy the inventory from the diagram to the tile.
- From a diagram, select a node and choose **Tiles, Add Selected Node to Tile**, select the tiles to update, and then choose **Save**.
- To remove inventory or rename a tile, select a tile and choose **Tiles, Show/Edit Contents of Selected Tile**. Make your changes and choose **Save**.

Working with diagrams

Diagrams visualize your cloud resources with connections between resources to indicate data flow between cloud resources.

Add a diagram

1. From any tab, choose **Diagram**, and then **Add New Diagram**.
2. Enter a unique name for your diagram and choose **Proceed**.

Adding inventory

A resource can exist on more than one diagram. Add or remove inventory to and from diagrams to best suit your needs.

There are several ways to populate diagrams with inventory.

If you know the name of the resource

Use the keyword search at the top right of the page and drag the result from the bottom of the page to the diagram.

If you want to select items from the complete inventory

1. From the diagram's tab, choose **Diagram**, and then **Manage Diagram Contents**.
2. Identify and add items to the current diagram. The **Diagram Contents** box lists the downloaded inventory on the left side and the current diagram's contents on the right side. Use the buttons in the middle to add or remove nodes from the current diagram.
3. Choose **Save**.

Automatically expand the diagram

Media Services Application Mapper on AWS can automatically expand the diagram based on connections from existing nodes to nodes not yet on the diagram.

1. Populate the diagram with inventory.
2. Select (or multi-select) the applicable items on the diagram.
3. Choose **Diagram**, and then one of the following menu items to automatically expand the diagram's contents:
 - Add Downstream Connected Nodes
 - Add Upstream Connected Nodes
 - Add All Connected Nodes

The concept of upstream and downstream connections between nodes is related to the direction of the arrowhead on each connection and the implied data flow direction between nodes.

Connections to downstream nodes have arrowheads pointing to the other nodes, indicating data flowing in that direction. Connections to upstream nodes have arrowheads pointing at this node, indicating data flowing from those nodes into this one. Nodes can have zero or more upstream connections coming to it, and zero or more downstream connections going from it to other nodes.

Connections

Visual connections between nodes are automatically added to diagrams when discovered. They are also removed automatically by the tool when either or both nodes supporting the connection are removed from the diagram. The back-end rules are reevaluated periodically against the inventory to show new connections or expire old connections.

Custom connections

You can add custom connections between two nodes that do not have an existing connection (cannot be automatically discovered).

1. Select two nodes on the diagram without an existing connection.
2. Choose the **Create Connection** button (blue arrow) at the right of the navigation bar. The first node selected is designated as the upstream node and the second node selected is designated as the downstream node. The arrow points toward the downstream node.

To edit or delete the custom connection

1. Select a custom connection.
2. Choose the **Edit Connection** (blue pencil) or **Delete Connection** (blue no entry symbol) button at the right of the navigation bar. You can provide a connection label name and set an expiration date using the **Edit Connection** button.

Custom connections display the "user-defined": true attribute in the **Selected Item** compartment at the bottom of the page.

Diagram layout

When you have inventory on the diagram, you can organize the nodes to make the diagram meaningful. Reposition nodes manually by selecting and dragging nodes to a new position.

Navigation

- Fit and magnification buttons are located at the bottom left of the diagram.
- The fit button resizes the entire diagram to the visible page.
- Movement buttons are also located at the bottom left of the diagram.
- Select and drag the background of the diagram to reposition.
- Double-click a node or near a node to zoom in to it.

Selection

- Selection notifications are shown at the far right of the navigation bar.
- Use the Command or Ctrl keys with left-click to select multiple items.
- Select a group of items on the diagram by dragging with the right button pressed.
- Selected nodes can be moved by dragging the nodes with the left button pressed.

Diagram layout tools

Media Services Application Mapper on AWS includes several tools to help organize and layout diagrams.

Layout tools available from the **Diagram** menu:

- **Layout Hierarchical Top-Bottom** - Reorganizes the current diagram top to bottom.
- **Layout Hierarchical Left-Right** - Reorganizes the current diagram left to right.
- **Layout Isolated Nodes** - Lays out nodes without connections. This feature groups the same types of nodes together into a square.

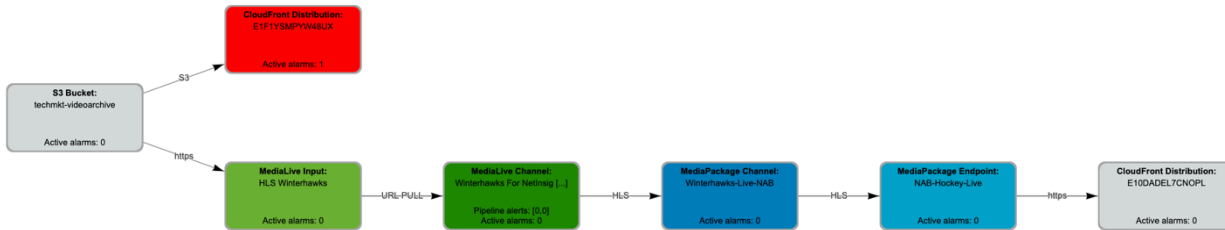
If your diagram contents don't look right, go to **Settings > Advanced Settings > Layout Method** and toggle the Layout Method between **Directed** and **Hub Size** to change how the diagram is organized. Some diagrams automatically layout better with one method over the other. One method prioritizes direction and the other prioritizes nodes with the most connections.

You can align sets of nodes vertically or horizontally using these tools from the **Diagram** menu:

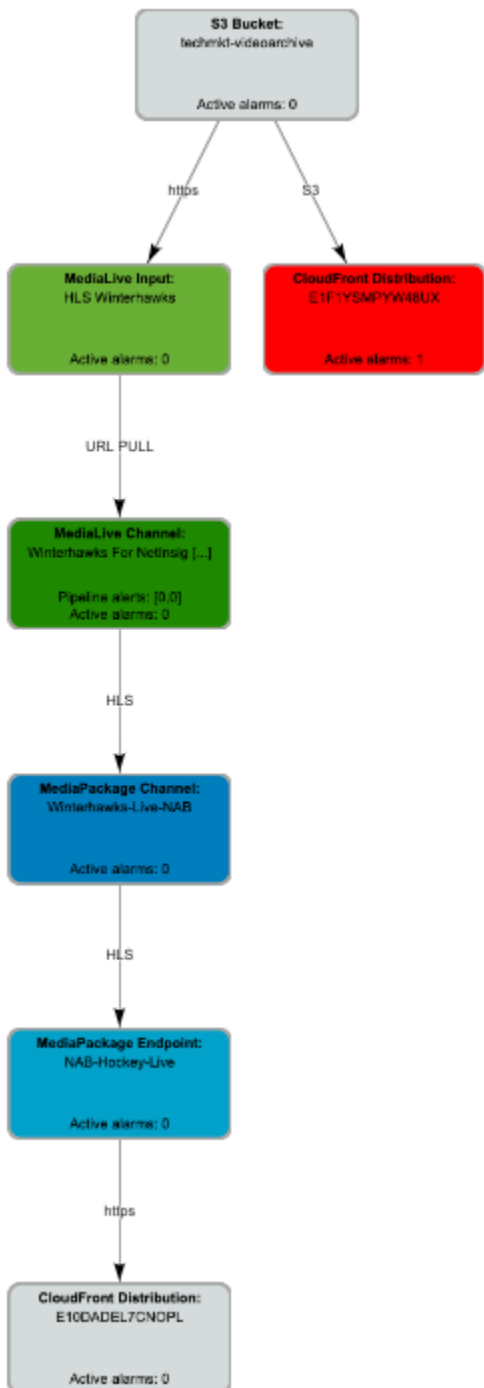
- **Align Selected Vertically**

- **Align Selected Horizontally**

Select all the nodes you want to align, select **Diagram**, then choose one of the alignment menu items.



Example diagram with horizontal alignment

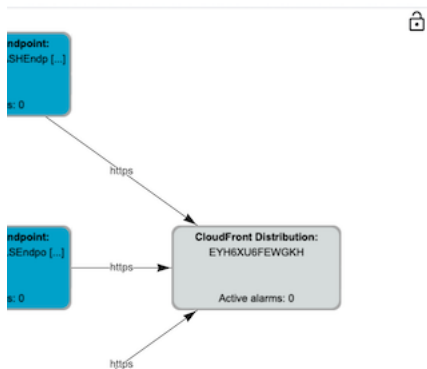


Example diagram with vertical alignment

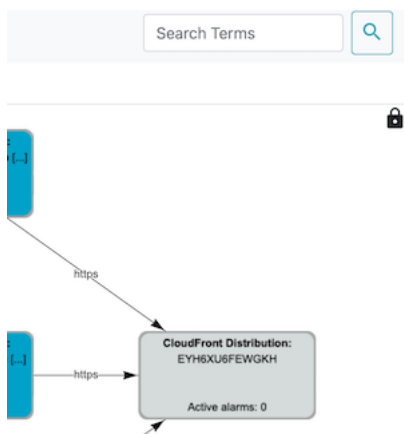
Locking diagrams from unintended changes

The solution's permissions model allows anyone with access to the tool to create and update diagrams. Lock a diagram from unintended changes by selecting the small lock icon at the top right of the diagram.

Locking a diagram prevents changes to the diagram's contents or layout. Anyone can view the diagram, select nodes, and monitor for state changes. Additionally, anyone can unlock a locked diagram to make changes. This additional step prevents unintended changes.

Managing the number of displayed diagrams

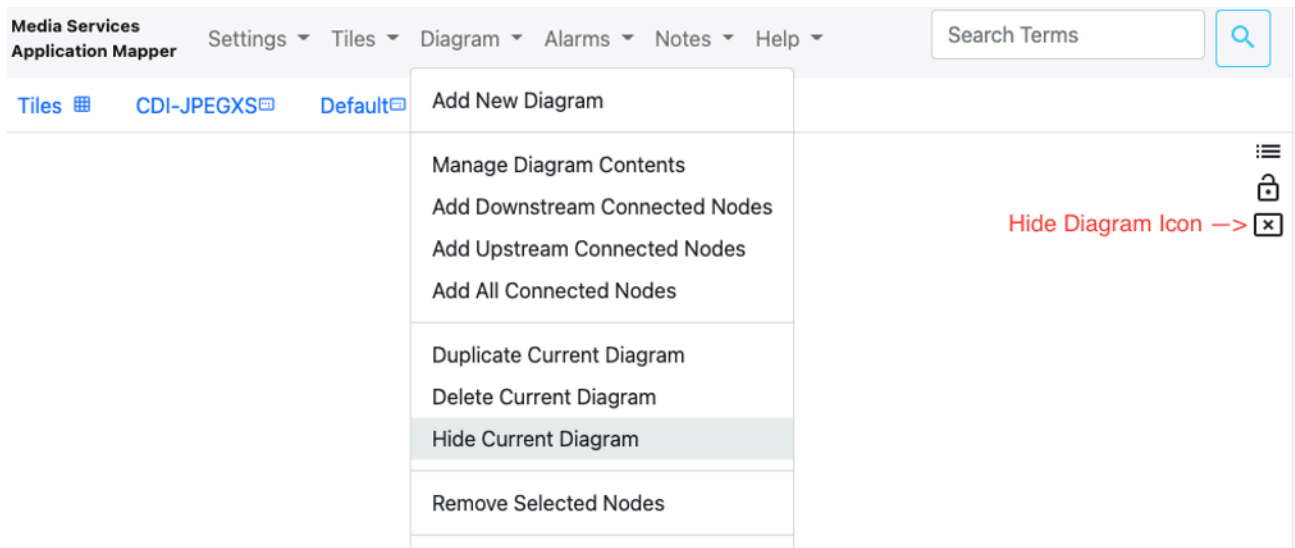
The maximum number of diagrams displayed at a time defaults to 10, but you can adjust this number using the **Settings > Advanced Settings > Maximum Number of Diagrams to Display** menu item. Once the maximum diagrams displayed has been reached, the application automatically hides the least recently viewed diagram when a new diagram is opened.

Hide a currently selected diagram in one of two ways

1. Select **Diagram > Hide Current Diagram** menu item.

(or)

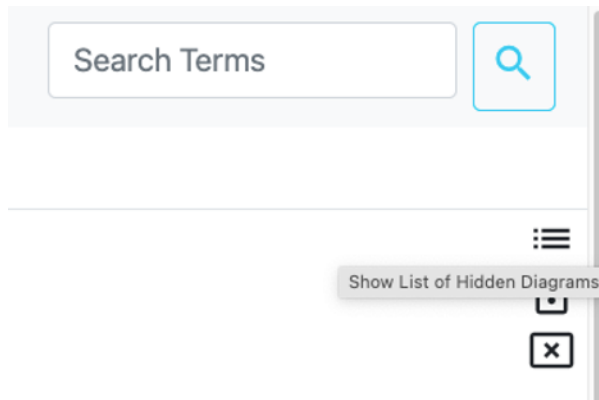
2. Choose the X icon at the top right corner of the diagram view.

Redisplay a hidden diagram in one of two ways

1. Select the small list icon just above the lock icon at the top right corner of either the tile or diagram view. Select a diagram to display.



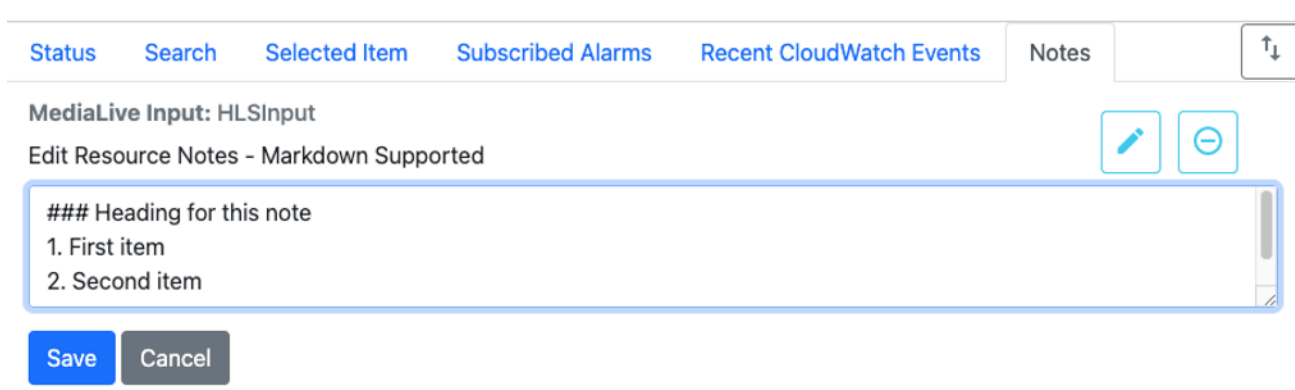
Redisplay hidden diagram

2. Choose the **Diagram** tab, then select **Add New Diagram** and enter the name of the hidden diagram.

Resource notes

Select any node or connection on your diagram or select a tile in the **Tiles** tab. From the bottom of the page, choose the **Notes** tab to attach notes to your resource. This solution supports Markdown format.

Notes field

View all resource notes using the **Notes > Manage Notes** menu item. From the **Manage Notes** window, you can filter notes by ARN, update time, notes content, and whether the resource associated with this note still exists. You can also edit or delete individual notes from this view. Notes are saved in a DynamoDB table and do not expire. To delete all notes, go to **Settings > Advanced Settings > Bulk Delete > Notes**.

Data freshness

The browser application loads inventory once while it is starting. It does not automatically show additions or changes in the cloud inventory. Refresh the browser page to retrieve the latest inventory from the cloud cache. Diagrams, tiles, and other settings will be restored from the cloud. Alarm and alert statuses of each resource in the inventory is updated on a periodic interval, which you can configure using the **Advanced Settings** menu item.

Searching for resources, diagrams, and tiles

Search controls are located at the upper-right of the page and inside the **Search** tab at the bottom of the page. Inventory in-memory, all diagrams, and tiles are searched simultaneously. Search results are displayed in the **Search** tab at the lower part of the page.

Search results show several results:

- Inventory - Matches that may or may not be on a tile or diagram.
- Diagram names - Names of diagrams that match search criteria.
- Diagram contents - Diagrams with inventory that match search criteria.
- Tile names - Names of tiles that match search criteria.
- Tile contents - Tiles with inventory that match search criteria.

You can add search results to an existing diagram or tile by dragging the item from the results compartment onto the diagram or tile.

User-defined nodes

This solution allows you to define your own nodes. For details, refer to the [REST_API.md](#) file on the GitHub repository.

Monitoring and alarms

Select any item on your diagram or select a tile in the **Tiles** tab. From the bottom of the page, choose the **Subscribed Alarms** tab or **Recent CloudWatch Events** tab and view alarms and alerts related to the resources contained by the selected item or tile.

CloudWatch events and media services alerts

Install the `msam-events-release.template` CloudFormation template in each AWS Region with your MediaLive channels or multiplexes, or MediaConnect flows. The solution automatically receives events and alerts and indicates them on the diagrams and tiles containing those resources. The visual items representing MediaLive change color as Pipeline alerts are set and cleared.

Media services alerts are represented in yellow or red, depending on the resource's total number of pipelines and number of pipelines currently experiencing a problem. If the number of pipelines

experiencing a problem is less than the total number of pipelines, the node is colored yellow to indicate the resource is still moving data but without full redundancy. If all the pipelines of a resource are experiencing a problem, then the node is colored red to indicate a failure.

CloudWatch alarms

Media Services Application Mapper on AWS can associate any CloudWatch alarm from any AWS Region to any node in its inventory.

To subscribe a resource to an alarm:

Note

You must create CloudWatch alarms in advance of performing these steps.

1. Select one or more resources on a diagram.
2. From the **Alarms** menu, select **Subscribe Selected to Alarms**.
3. Use the Region list and column filters to select one or more CloudWatch alarms.
4. Choose **Save**.

All tiles and diagrams containing this node will reflect the current alarm state.

To view the alarm:

1. Select the diagram node.
2. From the bottom menu, select the **Subscribed Alarms** tab.

The upper area of the **Subscribed Alarms** table contains subscribed alarms and the lower area contains MediaLive alerts. Use the control at the far right of the table to remove an alarm from a cloud resource. The diagram item shows a state change of any subscribed alarms.

CloudWatch metrics

Each of the solution's stacks sends metrics to CloudWatch to track the count of each type of resource known in its inventory. The solution queries its DynamoDB Content table for the count of fourteen different resource types, including MediaLive channels and inputs, MediaPackage

channels and origin endpoints, S3 buckets, and more. The solution sends these metrics to CloudWatch once per hour. Metrics are stored under the **MSAM** namespace in CloudWatch, with dimensions for the resource type and stack name. The stack name is a dimension in determining the resource counts since different stacks installed in the same account might be tracking different Regions.

You can use these metrics to set alarms to track inventory sizes in your account. For example, you could create an alarm for the following scenarios:

- The number of MediaLive channels is not equal to the number of MediaPackage channels.
- The number of buckets exceeds a threshold.
- There is a sudden change in the number of resources of a specific type (anomaly alarm).

Monitoring this solution with Service Catalog AppRegistry

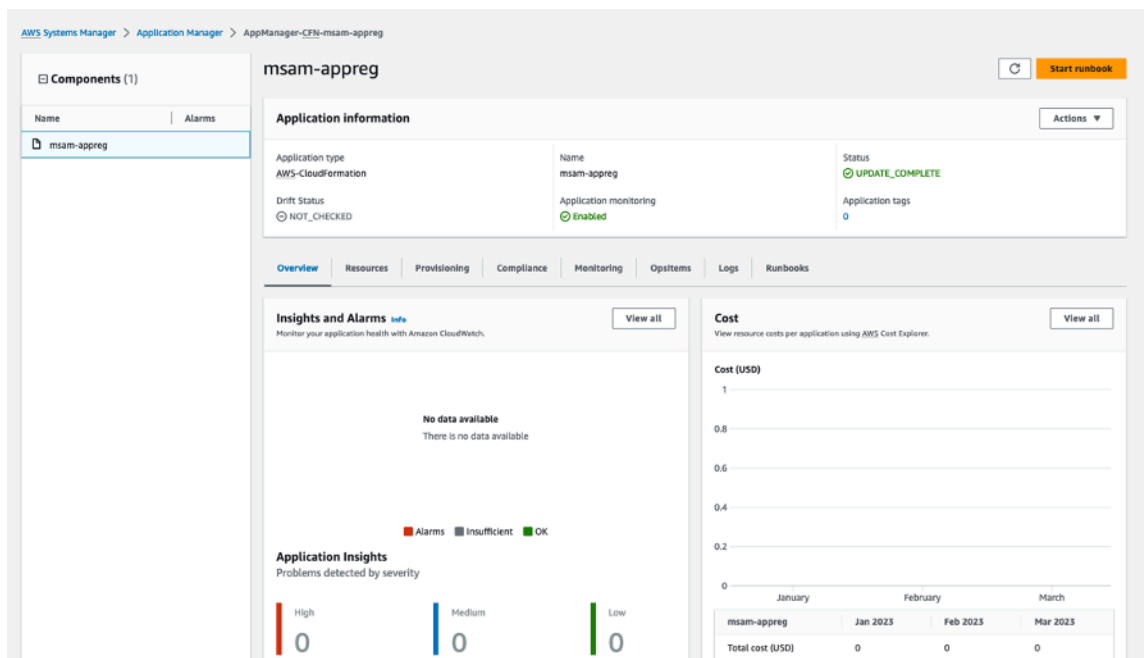
AppRegistry

The Media Services Application Mapper on AWS solution includes a Service Catalog AppRegistry resource to register the CloudFormation template and underlying resources as an application in both [AWS Service Catalog AppRegistry](#) and [AWS Systems Manager Application Manager](#).

AWS Systems Manager Application Manager gives you an application-level view into this solution and its resources so that you can:

- Monitor its resources, costs for the deployed resources across stacks and AWS accounts, and logs associated with this solution from a central location.
- View operations data for the resources of this solution in the context of an application, such as deployment status, CloudWatch alarms, resource configurations, and operational issues.

The following figure depicts an example of the application view for the Media Services Application Mapper on AWS stack in Application Manager.

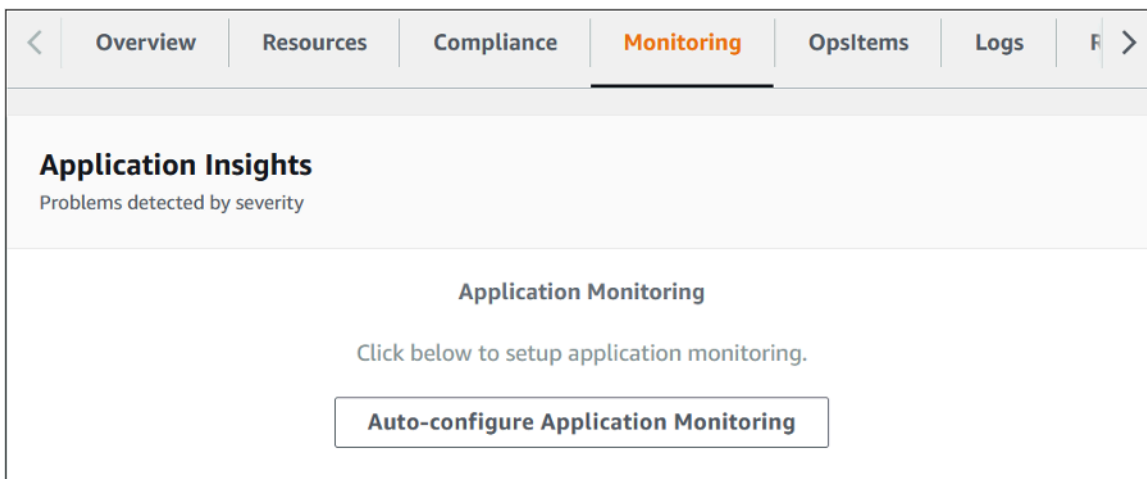
You must activate CloudWatch Application Insights, AWS Cost Explorer, and cost allocation tags associated with this solution. They are not activated by default

Activate CloudWatch Application Insights

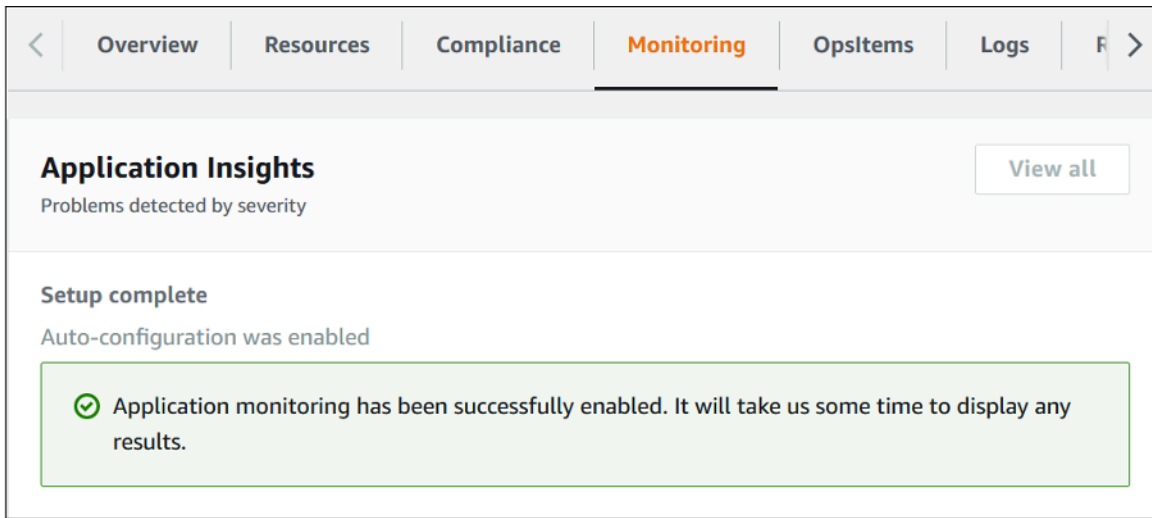
1. Open the [Systems Manager console](#).
2. In the navigation pane, choose **Application Manager**.
3. In **Applications**, choose **AppRegistry applications**.
4. In **AppRegistry applications**, search for the application name for this solution and select it.

The next time you open Application Manager, you can find the new application for your solution in the **AppRegistry application** category.

5. In the **Components** tree, choose the application stack you want to activate.
6. In the **Monitoring** tab, in **Application Insights**, select **Auto-configure Application Monitoring**.



Monitoring for your applications is now activated and the following status box appears:



Activate AWS Cost Explorer

You can see the overview of the costs associated with the application and application components within the Application Manager console through integration with AWS Cost Explorer which must be first activated. Cost Explorer helps you manage costs by providing a view of your AWS resource costs and usage over time. To activate Cost Explorer for the solution:

1. Sign in to the AWS Cost Management console.
2. In the left navigation menu, select **Cost Explorer**.
3. On the **Welcome to Cost Explorer** page, choose **Launch Cost Explorer**.

The activation process can take up to 24 hours to complete. Once activated, you can open the Cost Explorer user interface to further analyze cost data for the solution.

Activate cost allocation tags associated with the solution

After you activate Cost Explorer, you must activate a cost allocation tag to see the costs for this solution. The cost allocation tags can only be activated from the management account for the organization. To activate cost allocation tags:

To activate cost allocation tags:

1. Sign in to the [AWS Billing and Cost Management console](#).
2. In the navigation pane, select **Cost Allocation Tags**.

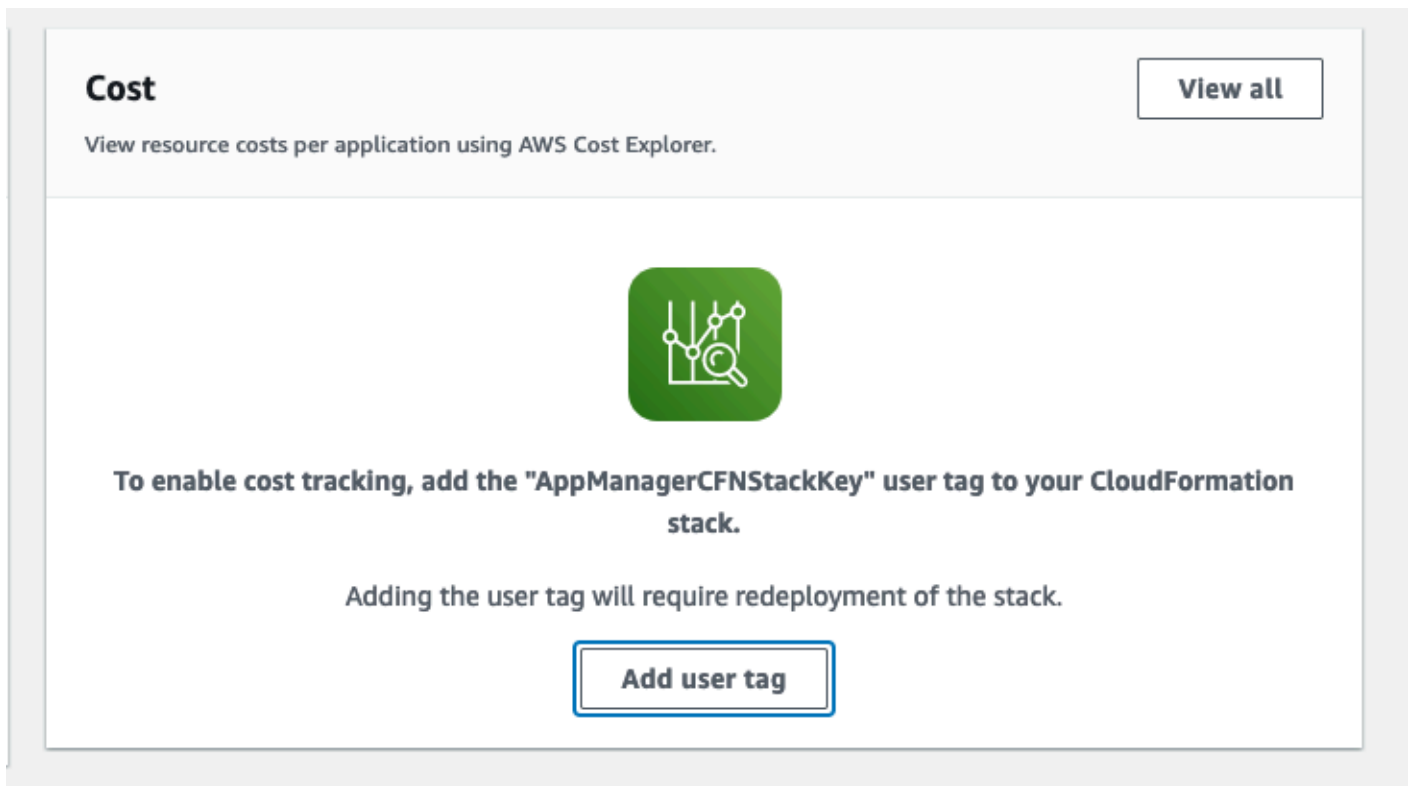
3. On the **Cost allocation tags** page, filter for the `AppManagerCFNStackKey` tag, then select the tag from the results shown.
4. Choose **Activate**

The activation process can take up to 24 hours to complete and the tag data to appear.

Confirm cost tags associated with the solution

After you activate cost allocation tags associated with the solution, you must confirm the cost allocation tags to see the costs for this solution. To confirm cost allocation tags:

1. Sign in to the [Systems Manager console](#).
2. In the navigation pane, choose **Application Manager**.
3. In **Applications**, choose the application name for this solution and select it.
4. In the **Overview** tab, in **Cost**, select **Add user tag**.



5. On the **Add user tag** page, enter `confirm`, then select **Add user tag**.

The activation process can take up to 24 hours to complete and the tag data to appear.

Update the solution

If you have previously deployed the solution, follow this procedure to update the Media Services Application Mapper on AWS CloudFormation stack to get the latest version of the solution's framework.

1. Sign in to the [AWS CloudFormation console](#), select your existing Media Services Application Mapper on AWS CloudFormation stack, and select **Update**.
2. Select **Replace current template**.
3. Under **Specify template**:
 - a. Select **Amazon S3 URL**.
 - b. Copy the link of the [latest template](#).
 - c. Paste the link in the **Amazon S3 URL** box.
 - d. Verify that the correct template URL shows in the **Amazon S3 URL** text box, and choose **Next**. Choose **Next** again.
4. Under **Parameters**, review the parameters for the template and modify them as necessary. Refer to [Step 1. Launch the root template](#) for details about the parameters.
5. On the **Configure stack options** page, choose **Next**.
6. On the **Review** page, review and confirm the settings. Be sure to check the boxes acknowledging that the template might create AWS Identity and Access Management (IAM) resources.
7. Choose **View change set** and verify the changes.
8. Choose **Update stack** to deploy the stack.

You can view the status of the stack in the AWS CloudFormation console in the **Status** column. You should receive a UPDATE_COMPLETE status in approximately 10 minutes.

Troubleshooting

This section provides known issue resolution when deploying the solution.

Issue: The CloudFormation template is taking longer than expected to deploy the stack.

Resolution

This solution installs a CloudFront distribution with the web application while the Amazon S3 bucket that hosts the content remains private. The first time installing the web application can take as long as 15-25 minutes for the CloudFront distribution to complete the deployment process. On rare occasions, it might take longer for CloudFront to complete its initial deployment.

Issue: I get a DNS redirect after navigating to the browser endpoint.

Resolution

You might receive DNS redirects or access denied from CloudFront for a short time if you install into a Region other than US East (N. Virginia). This is normal and might take from several minutes to an hour for DNS changes to propagate throughout the Amazon network. For more details, refer to [Temporary request redirection](#) in the *Amazon S3 User Guide*.

Issue: My installation is in US East (N. Virginia), but I need media services inventory from other Regions too. Do I install a copy of the solution in every Region?

Resolution

A single installation can collect inventory for all Regions within a single AWS account. By default, this solution only collects inventory from the Region in which it was installed. To collect inventory from more Regions, use the browser application. Choose **Settings, Advanced Settings**, and update the list of Regions in the **Inventory Regions** field. Choose **Save**.

Uninstall the solution

You can uninstall the Media Services Application Mapper solution from the AWS Management Console or by using the AWS Command Line Interface. To uninstall the solution, you must delete the solution's root CloudFormation stack, which deletes the other stacks and all of the resources created by the template.

Note

If you used separate template to install the solution, you must delete those stacks separately.

Using the AWS Management Console

1. Sign in to the AWS CloudFormation console.
2. On the **Stacks** page, select this solution's root installation stack.
3. Choose **Delete**.

Using AWS Command Line Interface

Verify that the AWS Command Line Interface (AWS CLI) is available in your environment. For installation instructions, refer to [What Is the AWS Command Line Interface](#) in the *AWS CLI User Guide*. After confirming that the AWS CLI is available, run the following command.

```
$ aws cloudformation delete-stack --stack-name <your-stack-name>
```

Replace *<your-stack-name>* with the name of your root CloudFormation stack.

CloudWatch event handler stack

Delete the CloudWatch event handler stack from any other Regions that were installed after you installed the main solution.

Deleting separate stacks

If you used separate templates to install the solution, delete the stacks in the opposite order they were installed.

The order in which to delete the stacks is as follows:

1. Browser application stack
2. CloudWatch event handler stack
3. Core API and periodic tasks stack
4. DynamoDB tables stack
5. IAM resources stack

Important

You must remove the DynamoDB tables stack after the Core API and periodic tasks and CloudWatch event handler stacks. These stacks run software that access the tables. Removing the tables before removing the running software has the potential to create excessive error rates in your account which might result in service usage throttling.

To delete a stack:

1. Sign in to the [AWS CloudFormation console](#).
2. On the **Stacks** page, select the stack.
3. From the **Actions** menu, select **Delete Stack**

Deleting the Amazon S3 buckets

This solution is configured to retain the solution-created Amazon S3 to maintain history. After uninstalling the solution, you can manually delete this S3 bucket if you do not need to retain the data. Follow these steps to delete the Amazon S3 bucket.

1. Sign in to the [Amazon S3 console](#).
2. Choose **Buckets** from the left navigation pane.

3. Locate the `<stack-name-msam-browserappmod-msambrowserapplogicbuc-xxxxxxxxxxxx>` S3 bucket.
4. Select the S3 bucket and choose **Empty**.
5. Choose **Buckets** and select the S3 bucket again.
6. Choose **Delete**.

To delete the S3 bucket using AWS CLI, run the following command:

DynamoDB table migration tool

The Migration Tool is a Python program designed to copy data from one DynamoDB table to another. You can use this tool to copy the contents of each of the solution's DynamoDB tables from one installation to another. There are several reasons you might want to do this:

- Setting up a duplicate system for production and test, with the same diagrams, alarms, and layout for both.
- Moving from an old to new installation of MSAM that cannot be upgraded with the templates.
- Using the [Point-in-Time Recovery](#) feature of DynamoDB to restore one or more MSAM tables to a previously known state.

Requirements

- Python 3.x installed and available from the command line
- boto3 package is installed and accessible by the above Python
- AWS CLI profile name that is configured to access the account and DynamoDB tables used by MSAM
- Source and destination DynamoDB tables are located in the same account and same AWS Region

Warning

This tool copies all records from one table to another without consideration for overwrite or data loss. It will overwrite existing keys in the target table if the same keys exist in the source table.

Example: Duplicating tables between two stacks

1. Sign in to the [AWS CloudFormation console](#).
2. Find the DynamoDB stack for the old and new stacks.
3. Record the table names for each stack.
4. Copy the tables from the old to new stack, skipping the DynamoDB Content table.
5. Start the new installation of the solution and verify tiles, diagrams, layout, and alarms.

If your source stack is missing a table, such as CloudWatchEvents, you can safely skip it.

Anonymized data collection

This solution includes an option to send anonymized operational metrics to AWS. We use this data to derive the scale, load, and storage needs placed on the application. The operational metrics consist of the maximum count of each resource type in the solution's inventory over the past 24 hours. The [CloudWatch metrics](#) generated on an hourly basis are used to generate the daily operational metrics.

If you have already installed the solution stacks, you can turn off anonymized metrics by deactivating the EventBridge rule. You can deactivate and activate metric gathering using this method without updating or changing the installation process.

1. Sign in to the [Amazon EventBridge console](#).
2. Find the EventBridge rule starting with the stack name and `ReportMetrics` in the name.

Note

By default, the rule is set to run every 24 hours.

3. Select the rule and choose **Disable**.
