Monitor Amazon WorkSpaces usage and optimize costs with the Cost Optimizer for Amazon WorkSpaces solution

Publication date: January 2017 (last update: September 2024)

The Cost Optimizer for Amazon WorkSpaces solution analyzes all of your WorkSpaces usage data and automatically converts the WorkSpace to the most cost-effective billing option (hourly or monthly), depending on your individual usage. Amazon WorkSpaces is a fully managed, secure Desktop-as-a-Service (DaaS) offering that eliminates the need for you to procure, deploy, and manage complex virtual desktop environments.

This solution helps you monitor your WorkSpaces usage and optimize costs and uses <u>AWS</u> <u>CloudFormation</u> to automatically provision and configure the necessary Amazon Web Services, Inc. (AWS) services to convert the billing mode for individual WorkSpaces. This solution supports a multi-account environment in <u>AWS Organizations</u> and is capable of running in the AWS GovCloud (US) Regions.

This implementation guide provides architectural considerations and configuration steps for deploying this solution on the AWS Cloud. It includes links to CloudFormation templates that launch, configure, and run the AWS compute, management, storage, and other services required to deploy this solution on AWS, using AWS best practices for security and availability.

This guide is intended for solution architects, business decision makers, DevOps engineers, data scientists, and cloud professionals who want to Cost Optimizer for Amazon WorkSpaces in their environment.

Features and benefits

The Cost Optimizer for Amazon WorkSpaces Solution provides the following features:

Dry run mode

We recommend that you run this solution in the dry run mode (activated by default) for a few months, review the daily and monthly reports, and manually implement any desired changes. Dry run mode provides insight into how the recommended changes may affect your WorkSpaces costs. This mode also allows you to evaluate and analyze the solution's recommendations without the solution automatically implementing billing changes. When you are comfortable with the recommendations provided by the solution and would like these recommendations to be automatically implemented, change the template parameter **Dry Run Mode** to No. The solution will then begin to automatically implement future billing changes based on the recommendations provided in its daily and monthly reports.

Automatic billing conversion

When the **Dry Run Mode** parameter is set to No, the solution converts a WorkSpace to monthly or hourly billing model, depending on the WorkSpace utilization for the given month. If WorkSpace utilization exceeds the usage threshold, the billing model changes to monthly on the day the utilization exceeds the threshold. The conversion from monthly to hourly mode happens on the last day of the month. If WorkSpace utilization for the month was lesser than or equal to usage threshold, the billing model changes to hourly on the last day of the month.

Features and benefits 2

Hourly to monthly

This solution calculates the hourly WorkSpace usage for each WorkSpace once per day, right before midnight GMT. This calculation includes that day's usage. When the **Dry Run Mode** parameter is set to No, the solution automatically converts individual WorkSpaces from an hourly billing model to a monthly billing model if the WorkSpace exceeds an hourly usage threshold for that WorkSpace type.

By default, the threshold is set close to the hourly and monthly billing break-even point. However, you can use the solution's hub template parameters to change the threshold for when each WorkSpace converts from hourly to monthly billing.

Note

Because the solution cannot convert WorkSpaces before the calculation at midnight, the default configuration may result in some WorkSpaces exceeding the threshold for up to 24 hours. For example, the default threshold for a Standard instance is set to 85. If, at midnight on Monday, your usage is 84, the WorkSpace will not be converted to monthly billing. If the usage exceeds 85 after midnight on Monday, the WorkSpace will not be converted until the calculation at midnight on Tuesday.

If several of your WorkSpaces consistently exceed the threshold before being converted, consider lowering the threshold. If several of your WorkSpaces are prematurely converted before exceeding the threshold, consider raising the threshold.

To mitigate this potential discrepancy, we recommend carefully monitoring your usage using dry run mode and adjusting the threshold to your needs before setting the **Dry Run Mode** parameter to No.

Once the solution converts a WorkSpace from hourly billing to monthly billing, the solution will not convert the WorkSpace back to hourly billing until the beginning of the next month, if usage was below the monthly usage threshold. However, you can manually change the billing model at any time using the AWS Management Console.

Monthly to hourly

For customers who want to convert WorkSpaces from monthly billing to hourly billing immediately, the solution's CloudFormation template includes a parameter (Simulate End of **Month**) that will run these conversions at the time of deployment.

Automatic billing conversion

Unused WorkSpaces termination

Important

Don't set the parameters Simulate End of Month Cleanup and Terminate workspaces **not used for a month** to Yes at the same time. Doing this will unexpectedly terminate WorkSpaces.

The **Simulate End of Month Cleanup** parameter will run the solution as if it's the last day of the month and then terminate WorkSpaces unexpectedly. To use the **Terminate unused** WorkSpaces feature, set Simulate End of Month Cleanup to No.

The solution provides a feature to terminate unused WorkSpaces permanently. By default, this feature is set to No, and you can allow this by selecting Yes or Dry Run for the input parameter **Terminate Unused WorkSpaces.**

You can use the input parameter **Number of months for termination check** to set the duration for the unused period. For example, if you select a value of two months, the solution will select the WorkSpaces that were unused for two months for termination.



Note

Opting into this feature terminates unused WorkSpaces and can cause changes to your existing CloudFormation stack. Changes to existing CloudFormation resources might cause a drift between the resource state and its definition in the stack. Ensure that these changes do not impact your existing resources and applications before opting into this feature.

For a WorkSpace to be eligible for termination, it needs to meet the following criteria:

- The WorkSpace is available from the first day of the unused period that you set.
- The LastKnownUserConnectionTimestamp, which indicates the last time a user logged into the WorkSpace, is earlier than the first day of the unused period that you set.
- The Launch in Dry Run Mode input parameter is set to No.

If this criteria is met, the WorkSpace will be eligible for termination. Then the solution checks for the following options for the parameter **Terminate Unused Workspaces**:

- Yes You can opt into this feature by selecting Yes for the Terminate Unused Workspaces input parameter. If opted in, the solution will identify all the WorkSpaces not used during the user-defined period based on the last known user connection timestamp. The solution will only terminate the WorkSpace if it met previously listed criteria
- Dry Run When you select Dry Run for the Terminate Unused Workspaces input parameter, the solution checks for all the conditions for a WorkSpace to be terminated and update the report, but it won't terminate the WorkSpace. The generated report will be marked as Yes- Dry Run for the WorkSpace.

Note

We recommend running this feature in Dry Run mode for the first few months and checking the monthly reports to review which WorkSpaces are marked for deletion.

• No – By default, the option is turned off (set to No). The WorkSpace will not be terminated and the report will not have any entry for this WorkSpace.

This check for terminating unused WorkSpaces will run only on the last day of the month or if the customers select Yes for the parameter Simulate End of Month Cleanup.

Opt out WorkSpaces

To prevent the solution from converting a WorkSpace between billing models, apply a resource tag to the WorkSpace using the tag key Skip_Convert and any tag value. This solution will log tagged WorkSpaces, but it will not convert the tagged WorkSpaces. Remove the tag at any time to resume automatic conversion for that WorkSpace.

Opt in Regions

This solution provides the **List of AWS Regions** input parameter, which specifies the AWS Regions monitored by the solution. You can provide a comma-separated list of AWS Regions that you want to monitor. If this input parameter is left blank, the solution will default to monitoring WorkSpaces in all the AWS Regions for the account.

Opt out WorkSpaces

Deployment in an existing Amazon VPC

This solution creates a new Amazon Virtual Private Cloud (Amazon VPC) to run the Amazon ECS task. If desired, you can deploy the solution in an existing Amazon VPC by providing the subnet IDs and security group ID as part of the input parameters to the CloudFormation template. To run the solution in an existing Amazon VPC, the Amazon ECS task needs to run in a public subnet, or a private subnet with a route to the Internet. This route is necessary because the Amazon ECS task will pull the Docker image hosted in a public Amazon Elastic Container Registry (Amazon ECR) repository. The security group used to run the ECS task will allow you to pull this image from ECR repository. To deploy the solution in an existing VPC select Nofor the input parameter Create New **VPC**. Provide the details for you existing VPC in the input section **Existing VPC settings**. Do not change the default values for the section **New VPC Settings**.



Note

In order for the solution to be deployed to a PUBLIC SUBNET, the subnet itself has to have auto-assign public IPs enabled.

Maintenance calculation

If you run your patches or other maintenance scripts by changing the WorkSpaces to ALWAYS_ON mode, you will need to account for the ALWAYS_ON hours and adjust the threshold values in the CloudFormation template accordingly. For example, if you change the mode from AUTO_STOP to ALWAYS_ON for 10 hours to run the maintenance scripts, you should subtract 10 hours from the set threshold value in the CloudFormation template.

Integration with Service Catalog AppRegistry and Application Manager, a capability of AWS Systems Manager

This solution includes a Service Catalog AppRegistry resource to register the solution's CloudFormation template and its underlying resources as an application in both Service Catalog AppRegistry and Application Manager. With this integration, you can centrally manage the solution's resources and enable application search, reporting, and management actions.

Use cases

Device management

As workforces increasingly become virtual, companies must grapple with device security, warranties, and delivery. By establishing thorough device management and policies, companies can spend fewer resources tracking devices or handling security breaches. Device management solutions help you secure your workforce's devices and provide options to meet different cybersecurity assurance levels. These solutions offer cost savings by reducing the number of devices needed, making management more efficient, extending the life of existing devices, and facilitating a bring-your-own-device policy.

Cloud financial management

Establishing visibility and usage analysis through spend dashboards, spend limits, chargebacks, anomaly detection and response, allows customers to identify opportunities to optimize expenses for cloud services. Customers can allocate current costs, plan and forecast future spend with the cloud financial management capability. This enables customers to track, notify, and apply cost optimization techniques across their environment.

Virtual desktop delivery

Whether in a workplace or classroom setting, desktop users need to be able to access their desktops and associated applications without delay. However, IT resource constraints and quality controls often slow down desktop delivery. Virtual desktop delivery solutions allow for faster and easier desktop-based application delivery. With these solutions, you can secure applications, build resiliency, and quickly scale to meet user demands—resulting in quantifiable savings and better data governance.

Architecture overview


This section provides a reference implementation architecture diagram for the components deployed with this solution.

Deploying this solution with the default parameters deploys the following components in your AWS account.

Note

This solution includes both a **hub account template** (deployed first) for a central account to manage the WorkSpaces and provide a centralized report, and a **spoke account template** (deployed second) for each WorkSpace account that you want to monitor. The solution generates a report per directory and an aggregated report with information about WorkSpaces from all the directories combined.

Cost Optimizer for Amazon WorkSpaces architecture

- The spoke template creates a custom resource that invokes an AWS Lambda function to register the account as a spoke account in an Amazon DynamoDB table in the hub account.
- 2. The hub template creates an Amazon EventBridge rule that invokes an Amazon ECS task every 24 hours.
- 3. The Amazon ECS task assumes an AWS Identity and Access Management (IAM) role in each spoke account to manage WorkSpaces.
- 4. The Amazon ECS task polls AWS Directory Service to gather a list of all directories registered for Amazon WorkSpaces in a specific AWS Region. The task then checks the total usage for each WorkSpace that is on an hourly billing model. If a WorkSpace has met the monthly usage threshold, the solution will convert the individual WorkSpace to monthly billing.

Note

If a WorkSpace starts in monthly billing or the solution converts a WorkSpace from hourly to monthly billing, the solution will not convert the WorkSpace to hourly billing until the beginning of the next month if usage was below the threshold. However, you can manually change the billing model at any time using the Amazon WorkSpaces console. Also, you can change the threshold for when each WorkSpace converts from hourly to monthly billing. For more information, refer to Automatic billing conversion

The solution also features a dry run mode (activated by default) that allows you to gain insight into how the recommended changes will affect your costs. For more information, refer to Dry run mode.

At the end of the month, the Amazon ECS task checks the total usage for each Workspace that is on a monthly billing model. If a WorkSpace has not met the monthly usage threshold, the solution will convert the individual WorkSpace from monthly to hourly billing at the start of the next month.

5. The Amazon ECS task writes the results of the execution to the DynamoDB usage table, session tables, and uploads them to an Amazon Simple Cloud Storage (Amazon S3) bucket.

Note

Check your Amazon S3 bucket frequently to track the optimizer's activity, and to view logs with error messages.

AWS Well-Architected design framework

We designed this solution with best practices from the AWS Well-Architected Framework, which helps customers design and operate reliable, secure, efficient, and cost-effective workloads in the cloud.

This section describes how we applied the design principles and best practices of the Well-Architected Framework when building this solution.

Operational excellence

This section describes how we applied the principles and best practices of the operational excellence pillar when designing this solution.

- The solution pushes metrics to Amazon CloudWatch to provide observability into the infrastructure, AWS Lambda functions, Amazon S3 buckets, and the rest of the solution components.
- The solution updates the daily report to indicate if the WorkSpace was skipped due to an application programming interface (API) failure.
- The solution provides a way to incrementally onboard spoke accounts when new WorkSpace workloads are added to the account.

Security

This section describes how we applied the principles and best practices of the security pillar when designing this solution.

- All inter-service communications use IAM roles.
- All multi-account communications use IAM roles.
- All roles used by the solution follow least-privilege access. In other words, they only contain minimum permissions required so that the service can function properly.
- All data storage, including Amazon S3 buckets and DynamoDB tables, have encryption at rest.

Reliability

This section describes how we applied the principles and best practices of the <u>reliability pillar</u> when designing this solution.

- The solution uses serverless AWS services wherever possible (such as Lambda, Amazon S3, and AWS Fargate) to ensure high availability and recovery from service failure.
- Data processing uses Lambda functions. The solution stores data in DynamoDB and Amazon S3, so it persists in multiple Availability Zones by default.

Performance efficiency

This section describes how we applied the principles and best practices of the <u>performance</u> <u>efficiency pillar</u> when designing this solution.

- All inter-service communications use IAM roles.
- The solution uses serverless AWS services wherever possible (such as Lambda, Amazon S3, and Fargate).
- The solution provides the ability to launch in any AWS Region that supports the AWS services used in this solution, such as AWS Lambda and Amazon S3.
- Automatically tested and deployed daily. This solution is reviewed by solution architects and subject matter experts for areas to experiment and improve.

Cost optimization

This section describes how we applied the principles and best practices of the <u>cost optimization</u> pillar when designing this solution.

- The solution uses serverless architecture, and customers pay only for what they use.
- The solution uses a lifecycle policy for the Amazon S3 bucket to delete objects after a year to help reduce the storage cost.
- The solution provides a feature to terminate unused WorkSpaces to help you save costs by reducing the operating workloads.

Sustainability

This section describes how we applied the principles and best practices of the <u>sustainability pillar</u> when designing this solution.

- The solution uses managed and serverless services to minimize the environmental impact of the backend services.
- The solution's serverless design is aimed at reducing the carbon footprint compared to the footprint of continually operating on-premises servers.
- Solution provides a feature to terminate unused WorkSpaces to help minimize the carbon footprint further.

AWS Organizations support

The solution supports AWS Organizations through a hub-and-spoke architecture. To monitor WorkSpaces across multiple accounts in your organization, allow trusted access for AWS Resource Access Manager (AWS RAM) in the management account of your Organization. For more information on how to allow trusted access for RAM, refer to AWS Resource Access Manager and AWS Organizations.

You can deploy the hub template in the central account, and then deploy the spoke template in each account that manages WorkSpaces. The spoke stacks must be deployed in the same Region as the hub stack.

For a multi-account deployment, provide the value for the **Organization ID for multi account deployment** and **Account ID of the Management Account for the Organization** input parameters. For a single-account deployment, or to manage WorkSpaces only in the central account, deploy only the hub template and leave the default value for the input parameters **Organization ID for multi account deployment** and **Account ID of the Management Account for the Organization**.

Plan your deployment

This section describes the cost, security, and quota considerations prior to deploying the solution.

Supported AWS Regions

You must launch the solution in an AWS Region that supports AWS Lambda, Amazon WorkSpaces, and AWS Fargate services. However, once deployed, the solution will monitor the WorkSpaces in any AWS Region. The solution can also monitor the WorkSpaces in the AWS GovCloud (US) Regions. After you deploy the solution in an AWS GovCloud (US) Region, the Amazon ECS task will pull the Docker image hosted in the AWS public Amazon ECR repository and monitor the workspaces in the AWS GovCloud (US) Region.

Cost

You are responsible for the cost of the AWS services used while running this solution. The total cost of running this solution depends on the number of WorkSpaces that this solution monitors. As of the latest revision, the cost for running this solution with default settings in the US East (N. Virginia) Region is approximately \$5.00 per month for a deployment with 1000 WorkSpaces. This reflects AWS Lambda, Amazon CloudWatch, and AWS Fargate charges and does not include the cost of the individual WorkSpaces (refer to Amazon WorkSpaces Pricing). You will also incur variable charges from Amazon S3. For a detailed cost breakdown, refer to the following examples.

We recommend creating a <u>budget</u> through <u>AWS Cost Explorer</u> to help manage costs. Prices are subject to change. For full details, see the pricing webpage for each AWS service used in this solution.

CUDOS Dashboard

While this solution helps you optimize WorkSpaces costs, to see the actual cost savings, you can also deploy a CUDOS dashboard by following the steps in our <u>CUDOS Dashboard lab</u> and see the metrics for the cost saving. After deploying the CUDOS dashboard, you can navigate to the **End User Computing** tab to see the graphs for **Average Workspaces Cost per region** and **Workspaces spend per region**.

the value for your location. Pricing differences between AWS Regions can mean a different billing break-even point between AutoStop and AlwaysOn instances.

Security

When you build systems on AWS infrastructure, security responsibilities are shared between you and AWS. This <u>shared model</u> can reduce your operational burden as AWS operates, manages, and controls the components from the host operating system and virtualization layer down to the physical security of the facilities in which the services operate. IAM roles

This solution creates IAM roles to control and isolate permissions, following the best practice of least privilege. The solution grants services the following permissions:

Hub template

Register Spoke Accounts Function Lambda Role

Write permission to Amazon DynamoDB table where spoke accounts are registered




Monitor the solution with AppRegistry

Solution stack in Application Manager


Operation Insights Dashboard



 - Paste the link in the Amazon S3 URL box.
 - Verify that the correct template URL shows in the Amazon S3 URL text box, and choose Next.
 Choose Next again.
- 4. Under **Parameters**, review the parameters for the template and modify them as necessary. Refer to Step 1: Launch the stack for details about the parameters.
- 5. Choose Next.
- 6. On the **Configure stack options** page, choose **Next**.
- 7. On the **Review** page, review and confirm the settings. Be sure to check the box acknowledging that the template might create (IAM) resources.

Known issue resolution

Failed WorkSpaces

The solution will attempt to modify WorkSpace mode based on the threshold hours. When the solution cannot change the WorkSpace mode due to an exception, such as the workspace being in **UNHEALTHY** state or booting up during the conversion, the solution will skip this WorkSpace and continue to process other workspaces in the account. The skipped workspaces will be added to the daily report with the message Failed to change mode. You can find more details about the exception in the Amazon ECS logs. The solution will attempt to change the mode again during the next run of the Amazon ECS task.

The solution creates log group and log streams to store logs each run of the Amazon ECS task. To get detailed information on the steps that happened during the solution run, enter the Debug option for the parameter **Log Level**.

If the you think that the solution did not work as expected or if the report was generated on a certain day, you can find more information about the solution run in the logs for the Amazon ECS task. The easiest way to access the logs is to filter the resources section of the CloudFormation stack by **CostOptimizerLogs** and select the link for the logs. This will take you to the log group in the CloudWatch service console. From here, you can open the log stream for the day you want to analyze the logs for errors.

If you need more information about a particular WorkSpace, search the logs with the **WorkSpace**ID of your WorkSpace to see more information filtered down to your WorkSpace.

Maintenance

This solution uses Docker images with fixed versions that match each solution release if automatic updates is not selected. The AWS Solutions team uses ECR Enhanced Scanning to detect Common Vulnerabilities and Exposures (CVEs) in the base image and installed packages. When possible, the team will publish patched images with the same version tag to resolve CVEs, without breaking compatibility with the released solution version. When images are patched, if they are on the same minor version, the stable tag will be automatically updated, and an additional image tag will be created in the format <code><solution-version>_<date-of-fix></code>. If a major or minor version is released, a full stack update will be required to get the latest image version as the stable tag will be incremented so that its version matches the version of the solution. If opting-in to automatic updates the changes to the image, including the CVEs and minor bug fixes, will automatically be applied to the image up to the latest matching minor release.

Versions

Customers on the latest solution version will receive security patches and minor, non-breaking, bug fixes automatically if they opt-in to automatic image updates. The image will automatically pull the latest image up to the latest matching minor version. In order to lock the container to a specific version, the task definition can be edited to specify the container to use a specific image version by using the tagged version of the image. Automatic updates can also be turned off by selecting **No** to automatic updates in CloudFormation when launching the stack. This will launch the image version matching the solution version.
